Construction – the default is no, unless one of the exceptions exists.		✓	<p><b><u>Construction Exceptions:</u></b></p> <p><u>Projects Already Underway</u></p> <p>Projects already underway involving individual single-family homes, or an individual apartment unit where an individual already resides, with a construction crew of 5 or fewer individuals. This includes additions to single-family homes such as solar panels. Projects already underway involving a residential unit for which a tenant or buyer has already entered into a legally binding agreement to occupy the unit by a certain date, and construction is necessary to ensure the unit's availability by that date.</p> <p><u>Critical Business Functions</u></p> <p>Projects involving data centers or facilities that are critical to a business's ability to function.</p> <p><u>Emergency Repairs</u></p> <p>Any emergency repairs necessary to ensure the health and safety of residents.</p> <p><u>Facilities</u></p> <p>Projects involving facilities at which any one or more of the following takes place: the manufacture, distribution, storage, or servicing of goods or products that are sold by online retail businesses or essential retail businesses, as defined by EO 107 and subsequent Administrative Orders adopted pursuant to that Order.</p> <p><u>Government</u></p> <p>Any project that is ordered or contracted for by Federal, State, county, or municipal government, or any project that must be completed to meet a deadline established by the Federal government.</p>

Health Care

Projects necessary for the delivery of health care services, including but not limited to hospitals, other health care facilities, and pharmaceutical manufacturing facilities.

Law Enforcement Support

Any project necessary to support law enforcement agencies or first responder units in their response to the COVID-19 emergency.

Religious Facilities

Construction of new religious facilities or construction involving existing religious facilities shall be considered essential construction projects.

Residential Affordable Projects

Residential projects that are exclusively designated as affordable housing.

Safety

Any work on a non-essential construction project that is required to physically secure the site of the project, ensure the structural integrity of any buildings on the site, abate any hazards that would exist on the site if the construction were to remain in its current condition, remediate a site, or otherwise ensure that the site and any buildings therein are appropriately protected and safe during the suspension of the project.

Schools (Pre-K to 12)

Projects involving pre-K-12 schools, including but not limited to projects in Schools Development Authority districts, and projects involving higher education facilities.

			<p><u>Transportation Projects</u></p> <p>Transportation projects, including roads, bridges, and mass transit facilities or physical infrastructure, including work done at airports or seaports.</p> <p><u>Utility Projects</u></p> <p>Utility projects, including those necessary for energy and electricity production and transmission, and any decommissioning of facilities used for electricity generation.</p>

Golf Courses	✓		<p>Golf Courses must adopt policies that include, at minimum, the following requirements:</p> <ul style="list-style-type: none"> <li>a. Require that reservations, cancellations and pre-payments be made via electronic or telephone reservation systems to limit physical interactions;</li> <li>b. Stagger tee times so that they are 16 minutes apart to limit the amount of people on the golf course;</li> <li>c. Limit use of golf carts to single occupant only, excluding an individual's immediate family members, caretakers, household members, or romantic partners;</li> <li>d. Require frequent sanitization of high-touch areas including, at minimum, the cleaning protocols outlined in EO 133;</li> <li>e. Restrict players' ability to touch common surfaces when retrieving golf balls by installing pins, placing cups upside down or partly above ground, or utilizing a shallow cup;</li> <li>f. Close all golf center buildings, pro shops, and other buildings and amenities to the public;</li> <li>g. Remove bunker rakes and other on-course furniture like benches, water coolers, and ball washers;</li> <li>h. Ensure that the flagstick remains in the golf hole at all times, and instruct players to avoid touching the flagstick or hole;</li> <li>i. Discontinue club and equipment rentals;</li> <li>j. Prohibit the use of caddies;</li> </ul>

			<p>k. Limit tee times to two players, except for immediate family members, caretakers, household members, or romantic partners;</p> <p>l. Place additional restrictions on areas of the golf course, as necessary, to limit person-to-person interactions and facilitate appropriate social distancing, including but not limited to, specific holes, putting greens, FootGolf courses, and short game areas;</p> <p>m. Employees, players, and other individuals should wear cloth face coverings in all settings on the golf course where other social distancing measures are difficult to maintain, except where doing so would inhibit that individual’s health, or where the individual is under two years of age; and</p> <p>n. Require players to always maintain appropriate social distancing by remaining six feet apart from others.</p>

Hotels	✓		<p>Municipalities and counties may impose additional restrictions in response to COVID-19 on the ability of hotels, motels, guest houses, or private residences, or parts thereof, to accept new transient guests or seasonal tenants.</p> <p>The term “transient guest or seasonal tenant” shall not include: (i) individuals housed as a part of State-directed non-congregate shelter initiative, (ii) individuals taking temporary residence supported by Federal, State, or local emergency and/or other housing assistance, or (iii) healthcare workers taking temporary residence. Municipalities or counties may</p>

			<p>not impose restrictions in response to COVID-19 on the ability of hotels, motels, guest houses, or private residences, or parts thereof, to accept any such individuals.</p> <p>Municipalities and counties may not impose restrictions in response to COVID-19 on the ability of hotels, motels, guest houses, or private residences, or parts thereof, to accept any individuals who have no permanent housing to which they may safely or lawfully return. Examples of individuals who would satisfy this criteria include, but are not limited to, homeless individuals, individuals affected by domestic violence, or individuals in hotels or motels in compliance with a court order.</p> <p>As clarification, individuals who have no permanent housing to which they may safely or lawfully return and live at a hotel or motel on a continual basis are not considered “transient guests or seasonal tenants”, and thus are entitled to the protections against evictions included in Executive Order No. 106 (2020).</p>

Parks – County and Municipal	✓		<p>Counties &amp; municipalities may decide if their parks are open or closed (or decide that a particular county park or particular municipal park is open or closed).</p> <p>If counties and municipalities have any open parks, they must, at a minimum, do the following at those parks: close the same areas that are closed at state parks (“picnic areas, playgrounds, exercise stations and equipment, chartered watercraft services and rentals, swimming, pavilions, restrooms, and other buildings and facilities, such as visitor centers, interpretive centers, and interior historical sites”) and prohibit the same activities prohibited at state parks (“engage in picnicking, participate in organized or contact activities or sports, or participate in gatherings”).</p> <p>Counties and municipalities are free to add additional restrictions to any parks that stay open. If individuals violate those local ordinances, those are violations of the local ordinance, not violations of an Executive Order.</p>
