NOTICE TO BIDDERS

NOTICE is hereby given that sealed bids for the WESTVILLE AVENUE & CEDAR STREET POOL PAINTING for the TOWNSHIP OF WEST CALDWELL (OWNER) in the TOWNSHIP OF WEST CALDWELL, ESSEX COUNTY, NEW JERSEY will be received at THE OFFICE OF THE TOWNSHIP CLERK, MUNICIPAL BUILDING, 30 Clinton Road, WEST CALDWELL, NJ 07006-6704 ON **Thursday, February 28, 2013** at 10:00 AM prevailing time.

The work generally consists of the concrete preparation as directed and painting of the Township's public swimming pools all in accordance with the form of proposal, contract and specifications prepared by OMLAND ENGINEERING ASSOCIATES, INC., CONSULTING ENGINEERS, 54 HORSEHILL ROAD, CEDAR KNOLLS, NEW JERSEY 07927. Plans and Specifications have been filed at the office of the TOWNSHIP CLERK of the TOWNSHIP OF WEST CALDWELL and may be inspected by prospective bidders at that office during business hours. Bidders will be furnished with a copy of the Contract Documents, Plans, and Specifications at the office of the TOWNSHIP CLERK, TOWNSHIP OF WEST CALDWELL at their offices at 30 Clinton Road, WEST CALDWELL, NJ 07006-6704, (973-239-1410) on proper notice.

Bidders are notified that they must comply with the New Jersey Prevailing Wage Act (Chapter 150 of the Laws of 1963, as amended) and that award will not be made to any bidder whom the Commissioner of Labor and Industry does not certify.

Bids shall be submitted on the forms provided, in the manner designated therein and required by the Specifications. They must be enclosed in sealed envelopes, bearing the name and address of the bidder and the name of the project on the outside, addressed to the TOWNSHIP OF WEST CALDWELL and must be accompanied by a certified check, cashier's check, or bid bond in the form provided of not less than 10% of the amount of bid. Said check or bid bond may not be less than \$500 nor shall it be more than \$20,000 and must be accompanied by a Consent of Surety statement in the form provided from a Surety Company stating that the Surety Company will provide the bidder with a bond for 100% of the Contract amount in the event that the Contract is awarded to the bidder. A Non-Collusion Affidavit and a Record of Recent Contract Awards must also accompany the proposal on the forms provided.

This project will be subject to prevailing wage rates, Chapter 150, L. 1963 (N.J.S.A. 34:11-56 et. seq., which are appended to these Bid Specifications and on file in the office of the TOWNSHIP Engineer.

PROPOSAL FORMS SHALL NOT BE REMOVED FROM THE FORM OF PROPOSAL. PROPOSALS MUST BE MADE UPON THE BLANK FORMS PROVIDED AND SUBMITTED IN THE BOUND BOOK, WHICH SHALL BE LEFT WHOLE AND INTACT IN EVERY RESPECT.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27, the law against discrimination (Affirmative Action).

Bidders must also comply with the requirements of P.L. 1977, Chapter 33 amending the Local Public Contracts Law. Bidders must submit a statement setting forth the names and addresses of all the stockholders in the corporation or members of the partnership who own ten percent (10%) or more of its stock, or have a ten percent (10%) or greater interest in the case of partnership.

No bid may be withdrawn for sixty (60) days after the opening of bids. A Contract will be awarded to the lowest responsible bidder or all proposals will be rejected within sixty (60) days after the opening of bids.

The TOWNSHIP OF WEST CALDWELL reserves the right to reject all bids, to reject unbalanced bids, and to waive any informality in any bid.
